## Business Challenge

McWilliams Forge Company provides aerospace forgings and other precision components to the aircraft manufacturing industry around the world. McWilliams Forge relied heavily on tape backup for business continuity. The catalyst for finding a better way to protect and recover their data came after having a severe production server crash. To recover, the McWilliams Forge team spent more than 40 hours rebuilding the system. Though it worked, the recovery process was incredibly expensive, time consuming, and challenging for the team.

As a result, McWilliams Forge recognized the need to provide an enhanced disaster recovery solution as well as 24x7 application availability for business continuity. With the need to protect a new document management system and their SQL-based ERP suite, McWilliams Forge Company required a solution that:

- Was compatible with their existing clustered server system environment
- Provided failover capabilities for reducing down-time

## Solution
